

93RD INAUGURAL LECTURE: PROF. OLUTOYE ADVOCATES FOR A RENEWABLE ENERGY POLICIES

A Professor of Chemical Engineering in the School of Infrastructure, Process Engineering and Technology, Federal University of Technology, Minna, Engr. Prof. Moses Aderemi Olutoye has called on the government to shift focus to a renewable and sustainable feedstock as way to transform the country's economy to be less dependent on fossil energy.

He made the call while delivering the 93rd inaugural lecture of the University titled, "Transforming the Nigerian Economy to be less Dependable on Fossil Fuel: Advocacy for Sustainable Alternative" on Thursday, October 14, 2021 at the University Auditorium, Main Campus Gidan Kwano.

Prof. Olutoye expressed concern that over dependence on fossil fuel as a source of revenue generation is responsible for the worsening events in the natural physical outlook of the

environment, restiveness in the oil producing communities and insecurity in the land.

"The current economic system is undermining our prosperity as it is destroying the natural foundations of our commercial activity," the scholar lamented.

The don further stressed that a transformation is necessary for a benign environment to preserve the natural resources, adding that this will improve the well-being of the people.

Prof. Olutoye who highlighted that the advocacy for a renewable energy policy for the energy sector can achieve important outcomes such as, better resource management, innovations and productivity gains, reducing environmental damage and creating new markets and industries, also stressed the need for a deliberate government policy to

create incentives for any individual to invest in maintaining the quality of the environment.

He said other sectors of the economy, such as agriculture and manufacturing should be given the opportunity to thrive and support revenue from petroleum, especially now that the price of oil is nose-diving, adding that a boost in research and development in the energy sector for transformation from the present structure is also required.

Prof. Olutoye further buttressed that massive investment in the plantation of oil bearing plants and trees which have the potential of producing the feedstocks needed for the generation of renewable and sustainable energy that is environmentally benign should be encouraged thus, improving the economy and creating more jobs for our teaming youths.

regulations governing the conduct of examinations and being the maiden examination of the centre, they have been following up with the centre so that standards are not compromised." He hinted this while monitoring the conduct of the examinations.

The Dean expressed pleasure with the conduct of the examination, noting that there was integrity, transparency and professionalism by the centre and that the students have been well behaved.

The Centre Leader, Prof. Hussaini Makun, stated that as a centre of excellence with a good reputation globally and having some of the International Centres partnering as invigilators, he is positive that the examinations will be credible. He added that he is satisfied with the arrangement so far.

The Examinations Officer and Research Theme leader of Heavy Metals and Pesticides Unit, Dr. Alexander Ajai disclosed that, "60 postgraduate students from 7 countries namely Nigeria, Cameroon, Ghana, Kenya, Malawi, Sierra Leone and Uganda are concurrently writing their examinations."

Earlier on, the students receive lectures, present seminars and submit assignments online. Thirty-seven (37) lecturers comprising of national and international faculty from Nigeria, Belgium, United States, India, Benin Republic, Kenya, South Africa and Italy were involved in knowledge impartation to the students.

While students in Nigeria are writing the exams at FUT Bioinformatics Laboratory, students in other countries are writing the exams in ACEMFS partner institutions in their respective countries, with contacts from African Centre of Excellence (ACE) in such countries invigilating and sending pictures and videos of the exam progress.

ACEMFS offers Master of Technology (M.Tech) and Doctor of Philosophy (PhD) degree programmes in Molecular Biology and Bioinformatics, Food Safety and Toxicology. The 60 students writing the examinations comprise 36 M.Tech and 25 PhD candidates.

Commenting on the significance of having 70 students in a new program, Prof. Makun said, "The sheer number has improved our earnings.

The Vice-Chancellor, Federal University of Technology, Minna, Prof. Abdullahi Bala FSSSN has expressed gladness that the Postgraduate programmes have been making progress in spite of the challenges of funding and the advent of the COVID 19 pandemic.

The Vice-Chancellor made the declaration while reacting to the success achieved during the conduct of the maiden postgraduate examination of the Africa Centre of Excellence for Mycotoxin and Food Safety (ACEMFS) held on 4th October, 2021 at the Federal University of Technology, Minna.

The University helmsman noted that the fact that students of the centre have commenced their examination is testament to the perseverance and ingenuity of the ACEMFS staff and the support of FUT, Minna Management at ensuring that the ACE project progresses without hindrance.

Prof. Bala noted that the new postgraduate programmes introduced by ACEMFS have "broadened the range of programmes offered by the University, enhanced the University's global profile and furthered the internationalisation drive of the University."

In his remark, the Dean of Postgraduate School, Prof. Oladiran Abubakre, represented by the Deputy Dean, Prof. Israel Olayemi said, "the PG School has rules and
